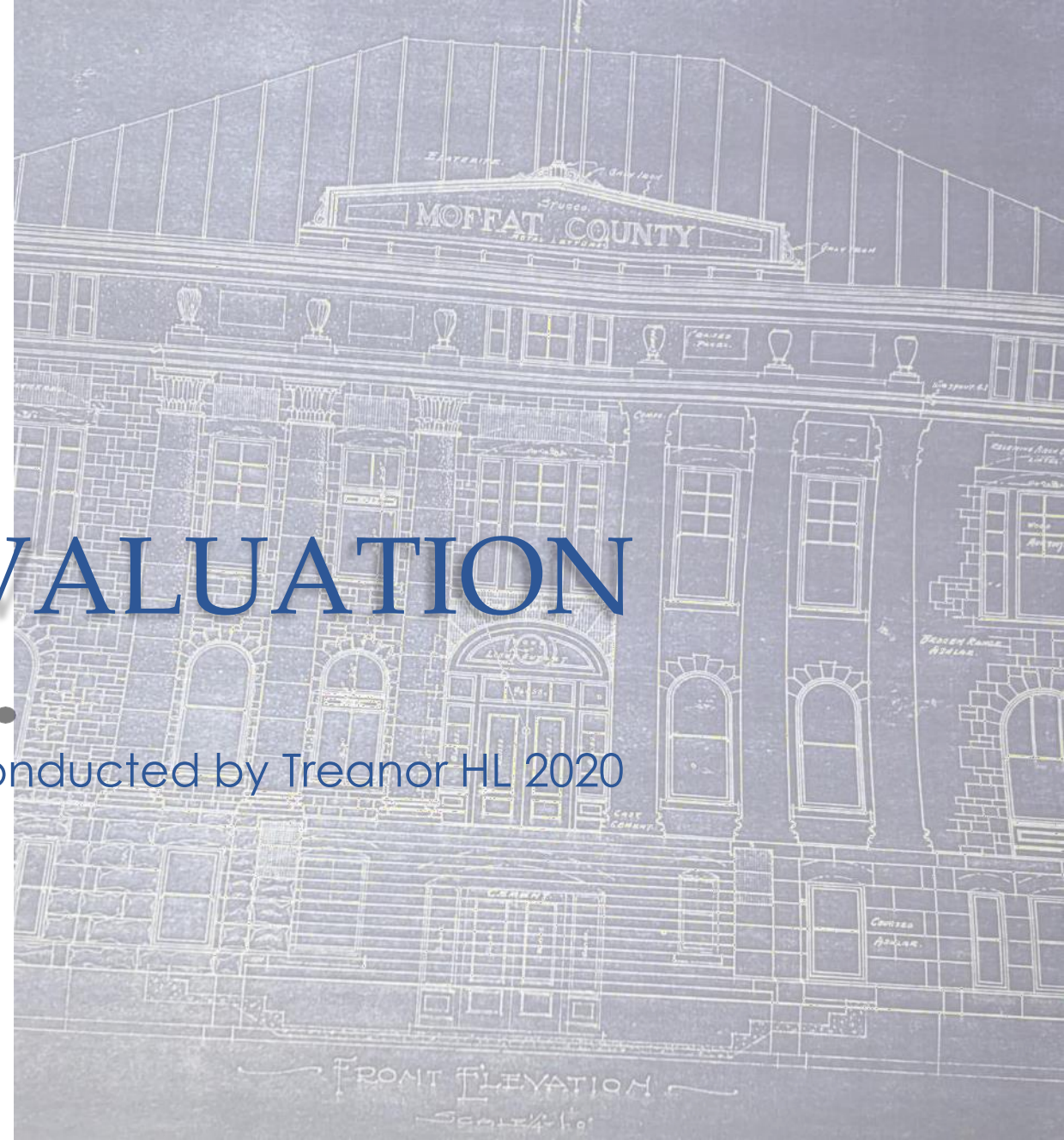

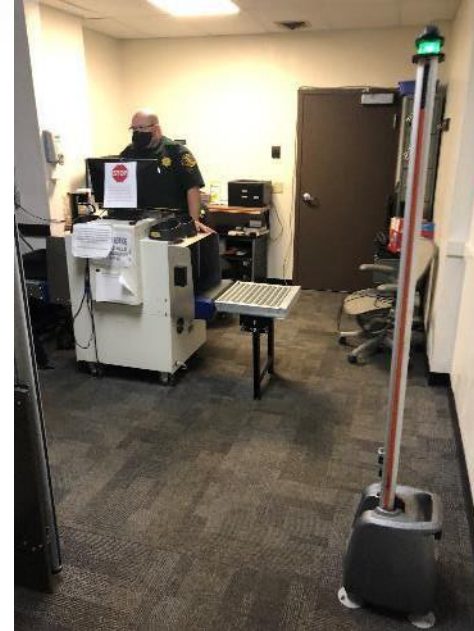
# COURTHOUSE

- Original building built in **1917**
- Renovation and Addition in **1932** and **1962**
- Three story facility
- 50,865 GSF



# COURTHOUSE

- Facility not compliant with current building codes or American with Disabilities Act
- No fire sprinkler system
- Substandard emergency egress from court floor
- Numerous problems with HVAC, electrical and plumbing
- Significant security issues with current facility
  - No enclosed delivery of in-custody persons
  - Undersized public screening
  - No separate circulation pathways for in-custody, public, and staff

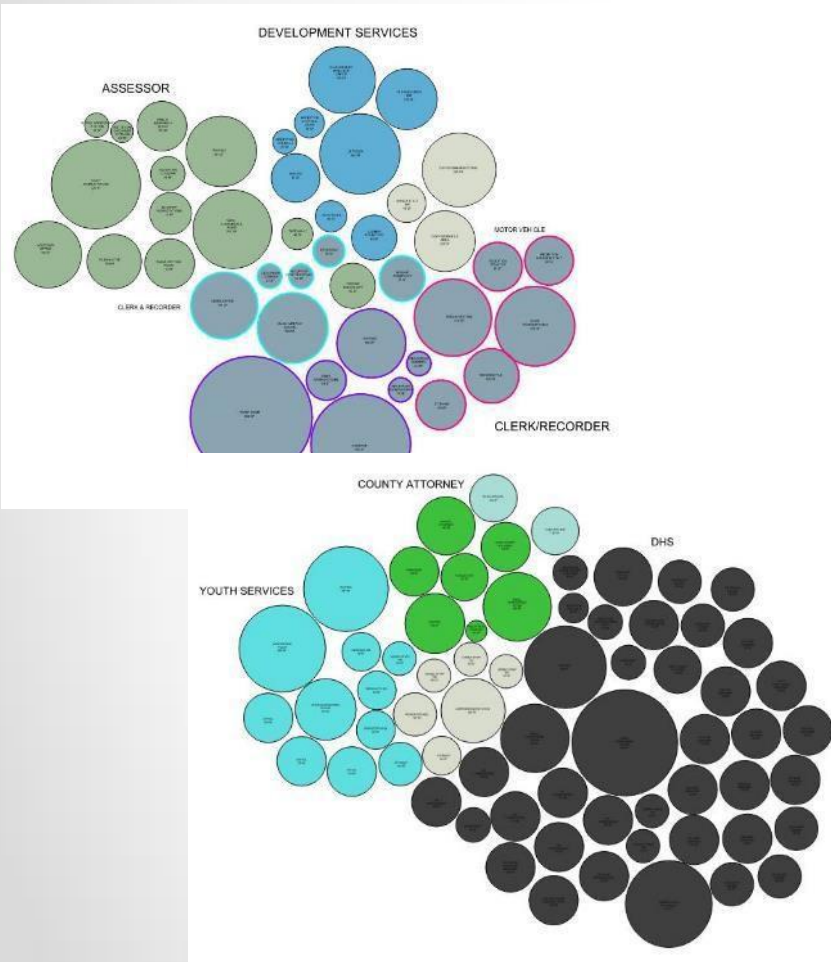

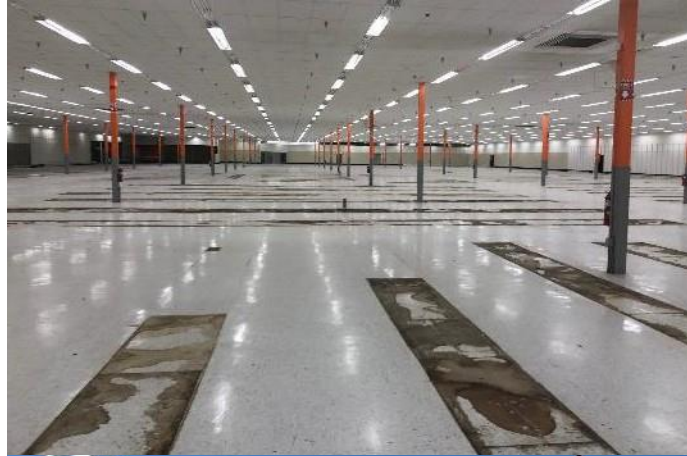
# Option 1, Renovate and add on to the existing courthouse

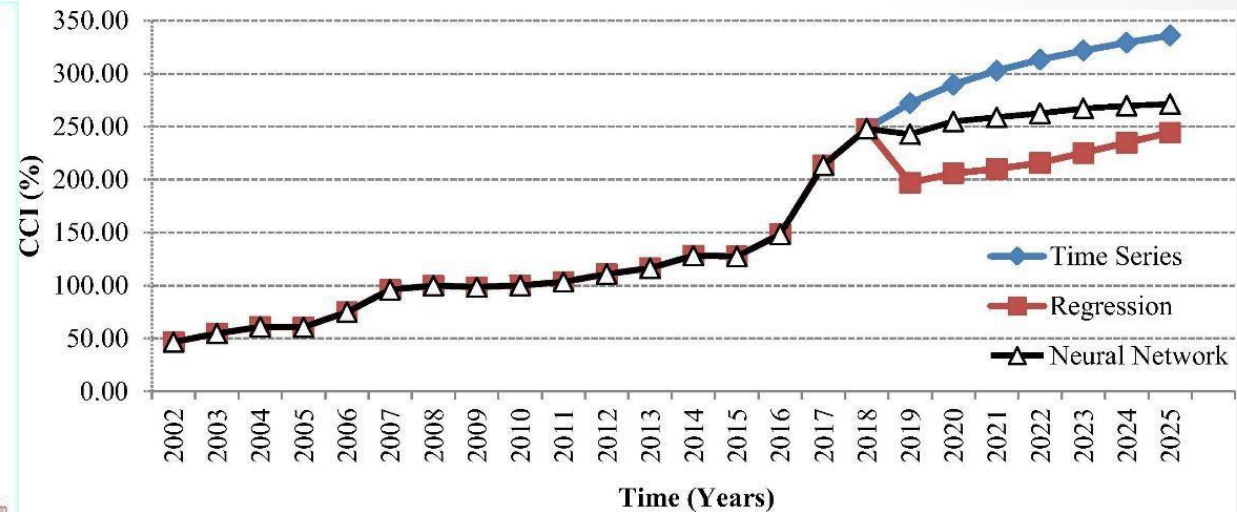
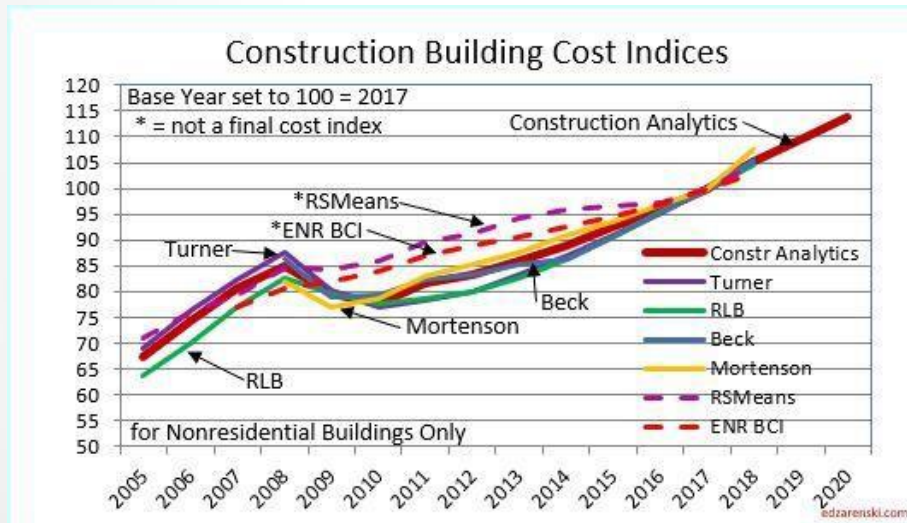


# PROJECT / CONSTRUCTION COSTS

# Next Steps

- Start design drawings and engineering December 2020
- Begin process to acquire new COP's
- Close on purchase of the Kmart building 12/29/20
- Working drawings 80% by March 1 2021
  - \$336,000
  - 60% Moffat County Administration Offices
  - 40% Judicial Office Space and Courtrooms
- Submitting a grant request for Phase 1 to DOLA March 1, 2021
- Financing (COP's) in place April 1, 2021
- Bid Documents ready and RFP released May 1, 2021
- Submitting a grant request for Phase 2 to DOLA August 1, 2021
- Construction begins September 1, 2021
