29 a. Paul Johnson, Student Legal Services
30 i. Student Legal Services (SLS) provides free, confidential legal advice and services for
31 current ISU students, spouse cardholders, and registered student groups
32 ii. SLS is located in 0367 Memorial Union, just across M-shop
33 iii. Services provided by SLS include: administrative law, criminal law, consumer issues,
34 employment issues, landlord-tenant issues, wills and powers of attorney
35 iv. SLS does not handle cases that involve student vs. student, student vs. university,
36 university disciplinary matters, and outside Story County
37 v. SLS was just recently added to the Dean of students website
38 vi. SLS began in 1985 with one part-time attorney. Prior to that year, ISU had a legal clinical
39 run by the Drake students
40 vii. Currently 22% of total students who use SLS are graduate students

- 1 viii. Services used by graduate students the most: notary services, issues with
2 landlords, creation of wills
- 3 ix. GSB continues to fund SLS: its library (in-office and online library), services,
4 transportation, etc.
- 5 x. Are appointments required?
- 6 1. A lot of times people can just walk in. We don't do phone consultations, as we
7 don't know who is calling us. This might be a problem for Vet Met. To solve this,
8 we try to have office hours on Wednesday mornings on Vet Med campus.
- 9 xi. Would someone be available for simple consultations if student is out of state?
- 10 1. Yes, we try to accommodate as many students as possible
- 11 xii. We get a lot of referrals – from parents (former ISU students), Ames court, and police
- 12 xiii. For more information, visit SLS website@ www.dso.iastate.edu/sls

- 14 a. Graduate Excellence Subcommittee (GES) updates, presented by Senator Pritchard
- 15 b. GES' objectives: increase graduate enrollment by 40% and increase graduate degrees awarded
16 by 20% in 4 years
- 17 c. URLA Chair Tlach: This is a part of dean's office initiative to keep ISU's membership. ISU is a
18 member of elite Association of American Universities. Our current graduate enrollment is what
19 we are lacking the most
- 20 d. Is it really a good idea to recruit graduate students within? We might be disadvantaging our
21 students by recruiting within. In some fields, employers don't like hiring someone who has
22 his/her undergraduate and graduate degrees from the same institution.

- 25 i. University is currently investigating diversity issues and outreach. If you have any input
26 or comments on this topic, feel free to contact me. I can either provide you with the
27 contact information or forward your feedback.
- 28 ii. GSB elections are over, GSB president-elect is Mr. Hughes. Several graduate students
29 were nominated for GSB Senator-at-large so potentially we might have all 3 Senators at
30 large for the next year. There were some issues with the graduate ballots. Several
31 graduate students voted for their academic college rather than Graduate College.
32 Graduate students should not be allowed to vote for undergraduate students.
- 33 iii. Associate VP of student affairs is stepping down, two candidates will be on campus next
34 week - April 2 & 3, 2-3pm.

3 graduate students an opportunity to earn additional travel funds through a once a year
4 phone and mail request to alumni and faculty. Only students who participate in this are
5 eligible to use this additional funding. Should GPSS consider this option as PAG
6 consistently runs out of money?
- 7 1. Why not consider utilizing surplus funds?
 - 8 a. This money is set aside to avoid running into negative balance
 - 9 2. All students should have an option to participate in this opportunity. However,
10 these funds should not be limited only to participating students.

2. CIO Prisacari: According to Student Activities Center policies, a student organization cannot function without a President and Treasurer. The Graduate and Professional Student Senate of Iowa State University is an elected body through which graduate and professional students express their concern for the welfare of graduate and professional students at the University, develop and disseminate ideas for the improvement of graduate and professional education, and contribute to the formation of relevant University policy. The Graduate and Professional Student Senate (GPSS) is the representative, deliberative, and administrative organization of the graduate and professional student body of Iowa State University, and is a duly constituted independent collegiate organization within the University.

ARTICLE I. THE GRADUATE AND PROFESSIONAL STUDENT SENATE

1. Representation. Each graduate department, interdepartmental, and professional program may elect one Senator for each fraction of ~~40~~ ~~(50)~~ one-hundred (100) graduate or professional students enrolled with a maximum of ~~5~~ ~~four (4)~~ Senators per department, where enrollment in a department, interdepartmental and professional program major is defined at <http://www.registrar.iastate.edu/enrollment/statsmajor>. Interdepartmental majors will be counted as members of their major rather than their home departments. Additionally, the special status of Senator-at-large shall be granted to the President and Vice-President of the GPSS and the Government of the Student Body (GSB). Senators representing the Graduate College.

2. Eligibility. Any student enrolled at least halftime (unless fewer credits are required in the final stages of their degree as defined by the Continuous Registration Requirement) in a graduate department, interdepartmental, or professional program at Iowa State University may be elected as a Senator. Each graduate/professional program may create more restrictive rules for electing Senators if they choose. Iowa State University and the

32 e. Serving as an investigative committee for the Senate when the occasion arises.
33 f. Work closely with the Senators-at-large to GSB on issues that concern both Senates.
34 g. Serve as a liaison to the GPSS regarding Board of Regents activities.

37 v. Professional Advancement Grant Committee. The Professional Advancement Grant Chair will work with a
38 representative from the Graduate College for travel awards, and form a committee to review GPSS awards
39 and scholarships.

1 2. Other Committees. The Senate may establish such other standing or temporary ad hoc
 2 committees as its business requires.

3
 4 3. Committee Chairpersons. All committees including University Relations and Legislative Affairs and
 5 Professional Advancement Grant, and University Relations and Legislative Affairs Committees shall have a
 6 chairperson. If a committee does not have a chairperson, the President of the Graduate and Professional
 7 Student Senate or the Senate shall appoint one.

8
 9 ARTICLE IV. ADVISER

10 1. The duties of the Adviser(s) shall include:

- 11 i. Be available to provide advice to Senators and Executive Council members.
- 12 ii. Act as a liaison with the University Administration and in any other situation where a non-student
- 13 spokesperson is needed.
- 14 iii. Maintain confidentiality on any information given or when advice is sought, except where violation of law
- 15 or University policy is at issue in the occasion of law or University policy violations.
- 16 iii-iv. Attend annual Advisor's training in compliance with Student Organization regulations.
- 17 iv-v. Sign all expenditures made by the organization.

18

 20 2. Selection. The Adviser shall be selected through consultation between the President of the Senate, and the
 21 Office of the Senior-Vice President for Student Affairs and the Office of the Senior-Vice President and Provost. A
 22 majority vote of the Senate shall be required to confirm the appointment of the Adviser.

23
 24 3. Term. The term of the Adviser shall be ongoing until resignation or removal by a two-thirds vote of a 60%
 25 ~~quorum~~ of the Senate. Selection of a new advisor shall proceed through procedures outlined in Article IV,
 26 paragraph 2.

 28 ARTICLE V. SUPREMACY OF RULES

29
 30 1. The following shall be the order of supremacy of rules and policies of the Graduate and Professional Student
 31 Senate:

- 32 i. Constitution
- 33 ii. Articles of Cooperation
- 34 iii. By-laws
- 35 iv. Acts of the Senate as passed through Senate Bill

36
 37 2. All acts and rules of the Senate shall be in accordance with applicable federal, state, and local laws as well as
 38 Iowa State University rules and regulations.

1 ARTICLE VI. FINANCES

2

3 1. All monies belonging to this organization shall be deposited and disbursed through a bank account established
4 for this organization at the Campus Organizations Accounting Office and/or approved institution/office (must
5 receive authorization via Campus Organizations Accounting Office). All funds must be deposited within 48
6 hours after collection. The Adviser to this organization must approve and sign each expenditure before
7 payment.

8

9 2. No dues shall be required for membership as a Senator.

10

11 ARTICLE VII. BY-LAWS, AMENDMENTS, AND RATIFICATION

12

13 1. By-Laws. A set of By-Laws shall be written and maintained to specify the rules for elections and rules of
14 procedure for the Senate and the Executive Council. Amendments to the By-Laws shall require approval from
15 two-thirds of all Senators present, where those two-thirds are also a majority of all Senators currently elected
16 and verified.

17

18 2. Amendments. Amendments to the Constitution may be initiated by the Senate, or by a petition to the Senate of at least one
19 hundred (100) combined graduate and professional students. An amendment must be approved at two senate sessions that are at
20 least two weeks apart. At each senate session, approval must be by two-thirds of all Senators present, where those two-thirds are
21 also a majority of all Senators currently elected and verified.

22

23 3. Ratification. This Constitution shall be ratified upon approval of three-fourths of the Senate.

24

25 If the Constitution or By-Laws are amended, the Chief Information Officer shall send an updated copy of both to the
26 Student Activities Center within ten days of the amendment.
