  - i. Discussion: VP Zenko requests CIO Singh to list the history of the discussion of GPSS representation for the Senate's benefit. Turns out that investigation of how Senate seats are allocated led to a discussion of an "improved" way to reflect how students have been represented. Special exceptions for some departments leads to (numerical) overrepresentations of some departments and some majors, including through a double-counting problem. By switching to major, we count everyone by individual participation rather than in the way that HCI students, for example, are being double-counted.

  - III. Graduate college is considering a new proposal on Graduate Student Annual Review. Please take a look at the attached document regarding this policy and provide feedback by April 5<sup>th</sup>.
  - IV. Execs meet with Keith Bystrom from Office of University Counsel regarding proposed changes in Student Disciplinary Regulations (Code of Conduct). Please provide feedback by April 5<sup>th</sup>. The draft changes are attached. Some of the important changes proposed are:
    - i. Expanding the All University Judiciary committee to potentially include more members.
    - ii. Changes in policies regarding Sexual Misconduct, Dating violence, stalking.
    - iii. Removal of All Residence Judiciary (ARJ) and All Greek Judiciary (AGJ) as they are not the currently used process.
    - iv. The terms Major and Minor violations are changed to Level 1 and Level 2 respectively.
    - v. Previously any charges for property damage / medical expenses that were over \$200 were considered Level 1. The new policy changes this is \$1000. This means we can expect higher number of Level 2 (Minor) charges and lower number of Level 1 (Major) charges.
    - vi. The Office of Equal Opportunity has stronger presence in the document.
    - vii. Misuse of computers is now misuse of technology.
    - viii. Interim actions is now interim measures
