32			obtain the slides to share with the Senate. I would like to send out the slides, and perhaps
33			Interim Director Corey Williamson can be invited to our March meeting to discuss more
34			details and answer any questions about the process. The approximate timeline to
35			completion is 5.5 years.
36			a. The referendum will NOT be ready by February 19th. A new goal of having it take
37			place in April has been set. The fee estimate is not 100% set in stone due to possible
38			fundraising, donations, and Presidential contributions.
39			b. A new Memorial Union website looks very slick and will hopefully be live by the end
40			of March. It is extremely visually pleasing and very user friendly.
41		vii.	Chapter 9 of the Graduate Student Handbook has been revised by the subcommittee of the
42			Graduate Council. This includes a section for Graduate Student Rights and Responsibilities

11		Supplemental International Tuition, her failure to acknowledge what was sent to her during
12		the Regents meeting, and the subsequent censure from Student Government. Regent
13		Johnson provided an explanation by e-mail (attached). This was forwarded to me by one of
14		our Senators-at-Large prior to the January meeting, and I expected that it would be brought
15		up in the discussion. For whatever reason, it was not.
16		a. I think it is important in the interest of fairness – but more importantly, in the interest of
17		future cooperative relationships – to invite Regent Johnson to a GPSS meeting so that
18		we can discuss how to better represent Graduate and Professional Student voices.
19		Regent Johnson expressed interest in coming to our April meeting to do so (see
20		attached).
21		b. In our January meeting, at least one of the comments made was unprofessional, and
22		decorum was not kept for a brief period of time. Please keep in mind that GPSS is a
23		professional organization, and professional behavior is to be expected. It is generally
24 25		helpful to act with professionalism and respect toward our guests, and doing otherwise reflects negatively upon GPSS. Disagreements, concerns, and criticisms are certainly
26		welcome and won't be censored, but personal attacks and inappropriate remarks should
20		be avoided.

3	ii.	I w	rote a report about the procedure and criteria followed by the PAG Committee regarding			
4		the	evaluation of the 32 applications of the Margaret Ellen White Graduate Faculty Award.			
5		Th	e report was sent to the Rules Committee and it is attached to the report. The main			
6		poi	ints of the report are:			
7		a.	Criteria of evaluation was established after the award deadline to avoid the Committee			
8			members could disclose this information to students in their home departments.			
9		b.	Criteria was stablished per each question of the form provided by the Graduate College.			
10		c.	A scale from 0 to 5 was established to score the applications being 0 the lowest and 5			
11			the highest score.			
12		d.	Each member of the committee was randomly given one question, and was responsible			
13			for evaluating only that particular question among the 32 applications. This was done in			
14			order to avoid bias from the answer of other questions that could make the members to			
15			give more weight to certain application instead of others.			
16		e.	Members of the committee did not evaluate applications coming from their department.			
17			All those evaluations were in conflict of interest and were evaluated by the PAG Chair.			
18		f.	Members of the committee sent their scores in a private e-mail to the PAG chair to			
19			avoid that other members see their evaluations and avoid bias of other members.			
20	iii.	Ad	ditional information has been provided from Senators George Weston and Senator			
21		Fał	bian Campbell, both Senators at Large, regarding the Margaret Ellen White Graduate			
22		Fac	Faculty Award. During an extraordinary meeting we discussed the following topics:			
23		a.	Concerns about the way the award was evaluated by the PAG Committee.			
24		b.	Concerns about the high percentage of recommended professors that came from			
25			Departments of the PAG Committee Members.			
26		c.	Suggestions to improve the evaluation process of the award in order to minimize bias			
27			coming from the PAG Committee members.			
28		d.	Suggestions to be presented to the Graduate College to clarify unknown topics related			
29			to the award.			
30		e.	The outcomes of the meeting were:			
31			1. It was seen that although the PAG Committee tried to avoid bias from different			
32			sources, other sources of bias were not avoided. Possible bias could be incorporated			
33			by giving the members of the committee all the information filled in the			
34			applications. This information could have been created an unconscious bias that			
35			could lead members of the Committee to give higher scores to certain professors if			
36			they know the Senators that endorsed some applications, especially those coming			
37			from the members of the PAG Committee.			
38			2. The suggestions that were given by the Senators in agreement with the PAG Chair			
39			are the following ones:			
40			1. Leave the information of the Nominee's names, department, nominator, and			
41			Senator that endorsed the application unknown (blanked or removed) for the			
42			evaluation of the applications by the members of the PAG Committee.
