Remarks and Reports

I. Report of the President

- i. I will be able to provide updates about meetings with Dr. Holger, the Policy Library Advisory Committee, and the Provost after the meetings. For now, the plan is to simply discuss Resolution S16-05 and the revisions to Chapter 9 of the Graduate Student Handbook. These meetings are scheduled for this week.
- ii. I met with Student Government and discussed the GPSRC, potential scholarships for Graduate Senators at Large, permanent Graduate/Professional Student representation on the Student Government elections committee (to prevent future instances of the issues presented during this election cycle, which included failures for some students to receive proper ballots), and revisions to the Articles of Cooperation (which have not been updated in several years). It will be up to the next Leadership of GPSS and the next Senate to ensure that these discussions are continued, and appropriate action is taken.
- iii. In the Policy Library Advisory Committee (PLAC) meeting, we discussed progress with the Chapter 9 (Graduate Handbook) revisions. The PLAC is a committee that has different stakeholders so when policy is revised, the different entities that it impacts can provide feedback. The Chapter 9 Review Committee (part of the Graduate Council, and includes me and GPSS URLA Chair) has been reaching out to different stakeholders by default. Still, this meeting was productive because the Graduate Council will have a member sit on the PLAC committee in the future, so communication is enhanced.
- iv. My meeting with the Provost was cancelled by me, due to illness. The Provost is working with the GPSS URLA Chair on a professional development seminar. In April, I will be sharing information about the Faculty Senate's conference about research ethics and misconduct. It will open up to Graduate and Professional Students in April and I highly encourage attendance. We have several GPSS members involved with a panel at the conference.
- v. Dean Holger will investigate statistics to determine the costs and benefits associated with the current late registration / registration change fee that we discussed in our last meeting (regarding S16-05). Having different policies for undergraduate students and graduate students is quite complicated, and I do not believe the Registrar will be interested in dealing with those issues. However, the Dean is (as usual) open to discussion and I passed on arguments and points from a constituent in the HCI program. These discussion points were considered very helpful. The discussion continues.
- vi. The Chapter 9 Revisions were discussed in the Graduate Council Meeting. Discussion was limited to the Rights and Responsibilities statement. The whole chapter will (hopefully) be voted on in the April meeting. If approved, it is expected to be passed on to the Provost and President for final approval. Faculty provided constructive criticism about the Rights and Responsibilities statement. A simplified version of the feedback follows:
 - a. Some of it reads as contentious, and it is unclear what happens if there is a disagreement. Language should be softened. It is also unclear what is encouraged as a

1 best practice and what is a fundamental right. The format does not fit with the rest of
2 the handbook.

- 3 b. Based on this feedback, the URLA Chair and I are leading a revision to this section of
4 Chapter 9 which will convert the rights and responsibilities to narrative format, begin
5 with a preamble that contextualizes the section and describes the recommended
6 approach for dealing with grievances. It will also, critically, distinguish between
7 fundamental rights (e.g., right to be respected) and best practices that are encouraged by
8 the graduate college, that are also discipline-appropriate (e.g., encouraged to attend
9 conferences and workshops). We were asked to work on an aggressive timeline, but that
10 is OK. It is too important for us to do otherwise.
- 11 c. The URLA Chair and I will pass along our revisions to the rest of the committee before
12 getting feedback from the Deans and the faculty members who raised concerns during
13 the Graduate Council meeting. Hopefully, we can bring forward a document that gets
14 approved in April.

15 II. Report of the Vice President

- 16 i. Constitution will be brought before the Senate again for a second procedural vote. No
17 amendments will be allowed, but we will allow discussion. No other legislation on the
18 agenda at this time.
- 19 ii. Our March 3rd social at Es Tas was quite successful. Thank you to everyone for your
20 contributions! Appetizers were available at the beginning and all students were offered two
21 tacos. At one point we hit capacity and had a waiting line outside. In total about \$938 (tip
22 included) was spent leaving about \$62 remaining in the mid-semester socials budget. We
23 estimate that this served approximately 170 students, which during my tenure would be the
24 highest mid-semester social attendance that I've seen. If it wasn't the highest in attendance,
25 then we can at least say that the quality of food and venue might have been one of the better
26 ones.
- 27 iii. Spring social has been scheduled to be close to the GPSRC as it has been in years past. It
28 will be Friday, April 15th @ 6:30-8:30pm in Perfect Games. It would be ideal to advertise
29 this alongside the GPSRC as much as we can to try to get the maximum number of
30 attendees. The cost of this event will be about \$1758 (tip included), which is over budget
31 for the spring, but with left over from the fall and mid-semester budgets I have been told we
32 should be fine.
- 33 iv. UT Arlington graduate students are considering a bill for maternity and paternity leave.
34 We provided them with our parental leave policy and hopefully that will help shape their
35 discussions. To remind ISU about our policy, GPSS President has suggested to the Daily
36 an article covering it and investigating its level of usage over the last 3 or 4 years since
37 adoption.
- 38 v. Student Government elections were March 1st and 2nd. There were some hiccups to say
39 the least. We tried to quickly and calmly address those, but the entire thing should have
40 been better. GPSS President is working with SG to improve processes for the future.
