# GRADUATE AND PROFESSIONAL STUDENT SENATE Remarks and Reports

#### I. Report of the President

- i. A tuition increase for international, nonimmigrant students has been proposed to the Board of Regents. This will be voted on in the December meeting of the Board of Regents. The plan would be to increase tuition by \$500.00 in the Fall of 2016. This would eventually result in tuition difference of \$1500.00.
  - a. This will NOT affect graduate students on an assistantship.
- ii. Reginald Stewart has been named the Vice President for Diversity and Inclusion and is expected to begin on December 1st. This will be voted on October 22nd, which will happen after this report is written and before our October meeting.
- iii. A student fee increase of \$33.50 will be voted on in the December meeting of the Board of Regents. This is meant to cover the updates and upgrades for student health services and additional costs of CyRide.
- iv. A motion has passed in the Graduate Council that will allow graduate students on restricted status to complete graded courses, rather than graduate level courses, from an approved plan of studies, count toward the progress to full admission status. DOGEs will have more information about this, but this essentially makes it easier for students to obtain full admission status. It does not impact the majority of students. However, for some students, it is critical.
- v. In the Graduate Council, I will be part of a subcommittee to review Chapter 9 of the Graduate College Handbook. We will discuss situations involving conflict between Graduate Students and Faculty, Graduate Assistant Rights, etc. This was formed last week. Expect updates in the future and, if you have valuable input, we will be seeking it.

### II. Report of the Vice President

- i. One bill was submitted by the Finance Committee. The Rules Committee reviewed the bill and found the bill favorable, i.e., adheres to the GPSS governing documents.
- ii. Working with the CIO to find a permanent fix to the senate representation issue raised at the last meeting by a student majoring in Environmental Science. When a fix is identified it will be brought to the Rules Committee to draft the appropriate changes to the GPSS governing documents.
- iii. Typically the social committee will plan one or more smaller socials throughout the school year. If GPSS would like to continue this, representatives are required on the Social Committee.
