 - iv. Treasurer: We have discussed the decreasing graduate student population. Professors are not receiving grants. Federal agencies are not giving the money they used to, many are on hiring freezes. Those who don't receive grants can't hire students. On the teaching side, decreasing enrollment decreases money, so the number of students that a TA has is increasing.
 - v. President: Current projections are for 17% reduction in applications. In-state applications have decreased 5-10%, international have decreased about 25%. Out-of-state applications are up about 13%. These numbers do not reflect who ends up coming to campus. Until this point, recruiting of international students has not been very intentional.
