VICE PRESIDENT

- 1) The latest draft of the Chapter 9 Graduate Student Rights & Responsibilities from the Graduate Handbook has returned from University Counsel and there appears to be no major issues that will keep it from being approved this semester. There will be an Ad Hoc Committee meeting to go over some small details, it should not have problems being passed by Graduate Council, and then I expect full approval from the Provost's Office.
- 2) Thank you to everyone that purchased tickets for *A Gentleman's Guide to Love & Murder*, which is taking place Tuesday, March 6, 2018. If the event is a success, I hope that this can become an annual event for GPSS, as Stephens Auditorium has been very accommodating.
- 3) The individuals that have been working on the Articles of Cooperation met with members of Student Government and we have an agreement on the table. Student Government will first pass a version and then that version will come to us to accept or deny. If there are no major changes to the Articles of Cooperation on their end, I believe no one in GPSS will have an issue with the new Articles. I will have a PPT slide that shows the expected changes when it comes to our budget at the Senate Meeting.

- 5) I will be recommending to the next Vice President to look at placing greater requirements in the rules when it comes to regular allocations requests for groups, especially for groups that fail to have consistent representation at GPSS Senate Meetings no matter how many senate seats they are allocated.

TREASURER

- 1) We have received regular allocation requests from 21 student and professional clubs. Total money request: \$19,481.30. Total Available for allocations: \$17,000.
- 2) PAG payments have been processed.
- 3) I have audited our accounts and I had meetings with the Graduate College, Campus Organization Accounting, and our previous GPSS Treasurer in order to prepare the cuts for the FY2018 budget. After these meetings it was possible to verify that the deficit is not as bad as we initially thought (\$7,988.13 instead of \$11,324.81)
- 4) BIG Thanks to the members of the Finance Committee (FC) for their involvement and help with the proposed cuts.
- 5) During March month, the FC will work on:
 - o Spring Regular Allocation Distribution
 - o Projected Budget for the FY2019
- 6) If we do not receive a bigger percentage from the Student Activity Fee and if we do not receive extra support from the Graduate College, we will need to make big adjustments to our expenses. This is not the last version of the budget, we still need to work on it with the FC, we are waiting for the vote on Student Government on the proposed Articles of Cooperation, and the Graduate College.


- 1) Two senators volunteered to operate the elections at the March meeting.
