Laboratory animals	The study did not involved laboratory animals
Wild animals	Hornet colonies were collected on the campus of Tel Aviv University in June 2021. The combs containing eggs, larvae, and pupae were excavated from the ground, and workers were collected from the excavated colonies using a sweeping net.
Reporting on sex	Hornet workers are all females, males appear in colonies later in the season (September/October).
Field-collected samples	The colonies were maintained in a climate-controlled room ($25 \pm 2^\circ\text{C}$, $75 \pm 10\% \text{RH}$).
Ethics oversight	No ethical approval or guidance was required as this study involves insects. Moreover, the Oriental hornet is considered as a pest nuisance, and is an invasive species. This species is thus not considered of concern for biological conservation.
